Timothy Scholarship Application

The Timothy Scholarship is specifically designed to aid families of KinderPrep – 8th graders, who are new to Christian education or have an unexpected financial struggle. The GCA Finance Committee will be reviewing the application at its earliest convenience. The Timothy Scholarship is awarded after all other scholarships (e.g., STO, ESA) and discounts are applied. As each application is unique, the Finance Committee will carefully consider the needs, and decide on an award. Keep in mind that not all applicants are guaranteed an award and that the decision of the Finance Committee is final.

To be eligible for tuition scholarship the student:

- Must need assistance as determined from application.
- Must meet entrance requirements as stated in GCA Policies and Procedures.
- Must be in good academic/behavioral standing.
- Must demonstrate efforts to submit applications to available School Tuition Organizations.
- Must have children currently enrolled at GCA.

Applicant Requirements:

- All applicable state and federal laws will be adhered to in the process of receiving and granting funds.
- Funds must be available before a scholarship is granted.
- Tuition scholarship will not be a cash expenditure to the student but will be credited to the student's tuition charges in the appropriate amount. In the event that a student should leave the school prior to the end of the tuition scholarship period, the remaining funds will be returned to the fund.
- Tuition scholarship is funded by:
 - Governing Board budgeted funds
 - Donations from individuals to the fund
- Funds received for scholarships will be accounted for according to financial policies and practices of GCC and GCA.
- Funds will be expended for tuition scholarship according to financial policies and practices of GCC and GCA.
- Tuition scholarship will not exceed 25% of the total tuition costs. Tuition scholarship will not be expended for registration fees.
- Tuition scholarship must be applied to current year.

Application Process:

- Those requesting scholarship must do so by completing the Timothy Scholarship Application.
- Applications must be updated annually by applicants seeking more than one year of assistance.
- Application packets may include but not be limited to the following:
 - Personal data (name, address, etc.)
 - Number of family members in household
 - Letters of Recommendation
 - Letter from Parents/Guardians
 - Letter from Student (parent can assist as needed)
 - Applications with School Tuition Organizations (i.e., ACSTO, SCA, etc.) or ESA
- Applications will be received, reviewed, and approved/denied by Finance Committee
- Administration will notify the recipients regarding the final decision
- Any fraudulent information given in the application process will be grounds for immediate disqualification of Timothy Scholarship funds.
